

#### **An Invitation To Act**

As the impacts of climate change become more apparent, business and institutional leaders need to develop strategies for business continuity and compliance in a new regulatory environment.

Commitment to a <u>9-month</u> collaborative planning process

We encourage each organization to appoint at least <u>2 staff</u> members to act as climate action leads

Appointed staff member(s) will attend <u>8-cohort work</u> sessions + lead weekly/bi-weekly meeting at their respective organization

Attend <u>3 planning checkpoints :</u> Kick-off, Summit, and Green Ribbon Cutting celebration. Open to organization leadership and additional staff.



#### **Collaborative Climate Action Planning Program**

The **City of Boston** has long-term climate goals for carbon reduction, resilience, and equity, as well as a Climate Action Plan. New regulations like the **Building Emissions Disclosure and Reduction** Ordinance (BERDO) are a key strategy for the City to meet its commitments. **City government** alone cannot meet the goals unless all private sector enterprises comply with **BERDO.** This program will support you to create the organizational strategies necessary for your company to meet your operational and mission aligned goals in today's changing environment.





#### **BERDO – Boston's Building Emissions Reporting & Disclosure Ordinance**

BERDO has changed the game, from reporting to compliance, starting in 2025. If you own any buildings of 20,000 square feet or more, now is the time to understand and make adjustments to your footprint, your future trajectory, and your CapEx plan. Carbon dioxide stays in the atmosphere for 300-1000 years\*, and every opportunity you have to reduce now saves lives in the long run. Let's go!



#### BUILDING EMISSIONS REDUCTION AND DISCLOSURE

Boston's Building Emissions Reduction and Disclosure Ordinance (BERDO) sets requirements for large existing buildings to reduce their greenhouse gas emissions over time.



### **Timeline & Process**

Each institution's climate action leader is given the tools and resources necessary to make planning progress at their organization. They will have time to do work in the meetings, learn from peers, and receive guidance from the experts in mitigation, resilience and climate justice who are dedicated to supporting the process. "Office hours" give the opportunity for questions and additional support between meetings.

## The Collaborative Planning Process was created with behavior theory and organizational change management as its framework.





#### Invaluable Learning through a Low-Cost Approach

Program Cost: \$5,000 for-profit; \$3,000 nonprofit

The Green Ribbon Commission's approach supports organizational competency. You manage your own climate planning process and implementation design.

While outside technical support may ultimately be required for systems changes and building retrofits, you will have a strategic understanding of your opportunities and requirements *through this highly subsidized program*.

The program's coaching, resources, and peer learning cohort *avoids thousands of dollars* in consulting expense to develop a coherent enterprise climate action plan.
